Symposium Topics

The Scientific Program Committee members, chaired by Professor Sun Choi (The College of

Pharmacy at Ewha Womans University) and Dr. Jung-Nyoung Heo (Korea Research Institute of Chemical Technology), are currently drafting the 20 plus scientific sessions, covering a wide range of topics concerning Medicinal Chemistry, Chemical Technology, Drug Targets as well as Chemical Biology-Driven Drug Discovery.

Other important scientific topics are also considered, and the Scientific Program Committee solicits your active participation in suggesting other interesting scientific topics that the committee should consider. The topic solicitation for scientific sessions will continue until the final program in May 2023.
